7.1 Water Orders 12 crates and under, if not in stock give us 24hours notice to deliver (working days only)

7.2 Water orders from 12 crates if not in stock give us 48 hours' notice (working days only)

7.3 Juice orders 3-5 crates give us 24 hours' notice to deliver

7.4 Juice orders 5 crates and above give us 48 hours' notice to deliver (working days only)

7.5 Juice products are made strictly by and to the orders of clients, and are not returnable after deliveries have been accepted.

7.6 All our Juice products have a shelve life of five (5) months from delivery date, and must be kept chilled once received, or if outside the fridge within 12-14 degrees

7.7 Juice products not appropriately kept by client and affected by temperature or otherwise will not be replaced by us.

7.8 We shall not be liable for the client's inability to sell our products, and products shall not be returned in such a case.

11. **If You Provide Your Own Labels:**

In the case you provide your own labels for us to stick them on our products for you, the cost of our labels will be deducted from our unit prices depending on the current value of the labels, but labor cost of labeling shall apply.

12. **If You Need Us to Make Your Own Labels:**

Should you need our products without our labels, and instead prefer your own branding and labels, and therefore instruct us to design and print them, the following terms and conditions shall apply:

- a. Designing of Main Artwork : R299.99 x 1 (once off)
- b. If designing more flavors of same artwork: R99.99 each (once off)
- c. Printing of labels: Minimum Qty Per Print of each = 200 pcs (*more prints lesser cost*)
- d. Cost of Printing labels: x each = to be determined by printing press per orders
- e. Artwork to be confirmed by client before printing (confirmation document will sent to and signed by client)
- f. Once artwork confirmed and printing started 0% refund on printing job.
- g. Full payment to be made by client before artwork/label designing commences.
- h. 100% upfront payment of cost of customized labels before printing will begin.
- i. All customized branding/label printing will require minimum of two business days' notice.

13. **SHELF LIFE**

Distributors/Sales Persons/Dealers/End Users

The shelf life of our Juices is +/- five (5) months from delivery date.
(*They are not produced in advance but strictly to and by order of clients*)

Once Received Please Keep 100%
Juices Constantly Refrigerated or if
Outside the fridge, must be in cool
environment of 14 degrees or
below. Don't keep crates of unused
juices behind or close to the fridge
because of the heat emitting from the fridge!

*Products damaged from high temperatures will not be
replaced by us!*

14. **RETURN POLICY**

Should our products be discovered to be damaged or affected otherwise unaware to us and you (the client) immediately upon delivery and receipt, complaint thereof shall only be attended to by us within twenty four hours (by calling) after receipt, thereafter we shall not accept liability thereof.
